### About the Scheme

The Irrigation Pricing Rebate Scheme (the Scheme) aims to lower the cost of water supplied by Burnett Water, Seqwater and Sunwater for commercial irrigation by owner-operated businesses. The Scheme provides a 15% rebate on the quarterly bills of eligible businesses in relation to the 2025-26 and 2026-27 financial years. Applicants may submit more than one paid bill as part of their application (based on the same customer number provided by Burnett Water, Seqwater or Sunwater).

Applications must be made by 31 December 2027 unless funding is exhausted prior. QRIDA assesses applications in order of receipt and will notify applicants in writing once decided.

### Required documents

Before starting this application, please have the following documents ready:

#### Owner-operated business

- Bill: you must submit at least one or more bills that have been paid and issued by Burnett Water, Seqwater or Sunwater. Bills must be related to a single customer number and in relation to the 2025-26 and 2026-27 financial years;
- Evidence of payment on each of the above water bill(s): evidence of payment must be in the form of a bank statement or bank receipt clearly showing the customer name and account details and evidence that the transfer of funds has been made. In some cases, a remittance advice from the water supplier may also be accepted if it clearly demonstrates that the invoice has been paid;
- Businesses primary production income: evidence such as a letter from a qualified accountant to demonstrate that the business or at least one owner of the business has declared primary production income for tax purposes, **or** a completed statutory declaration;
- Businesses irrigation activities: evidence such as management accounts, invoices for purchase of materials required for irrigation, Department of Primary Industries Farm Business Resilience Plan that mentions the need to irrigate **or** a completed statutory declaration;
- Bank account verification: Evidence from the bank (eg bank statement) to show that the nominated bank account to receive the rebate is in the name of the business applying for the rebate.

#### Irrigation entity

- Bill: you must submit at least one or more paid bills issued by Sunwater. Bills must be related to a single customer number and in relation to the 2025-26 and 2026-27 financial years;
- Evidence of payment on each of the above water bill(s): evidence of payment must be in the form of a bank statement or bank receipt clearly showing the customer name and account details and evidence that the transfer of funds has been made. In some cases, a remittance advice from the water supplier may also be accepted if it clearly demonstrates that the invoice has been paid;
- Bank account verification: Evidence from the bank (eg bank statement) to show that the nominated bank account to receive the rebate is in the name of the entity applying for the rebate.

***Please ensure all documents provided are clear and legible, and that all required information has been provided. If any of the information provided is incomplete, illegible, or missing, your application will be processed on the evidence available, which may result in your application being declined.***

## Fraudulent applications

## Section 4 - Arm's length engagement
